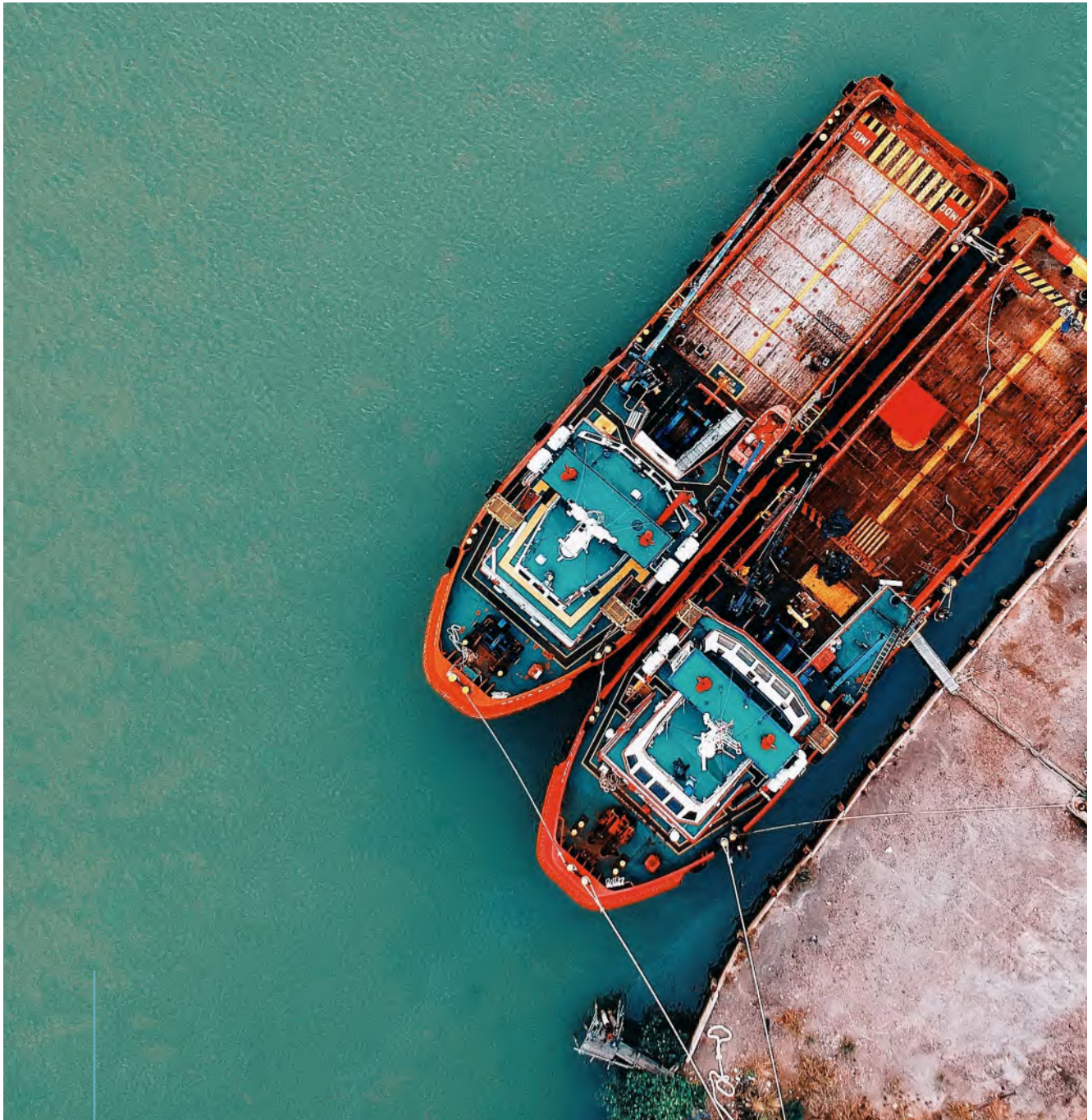

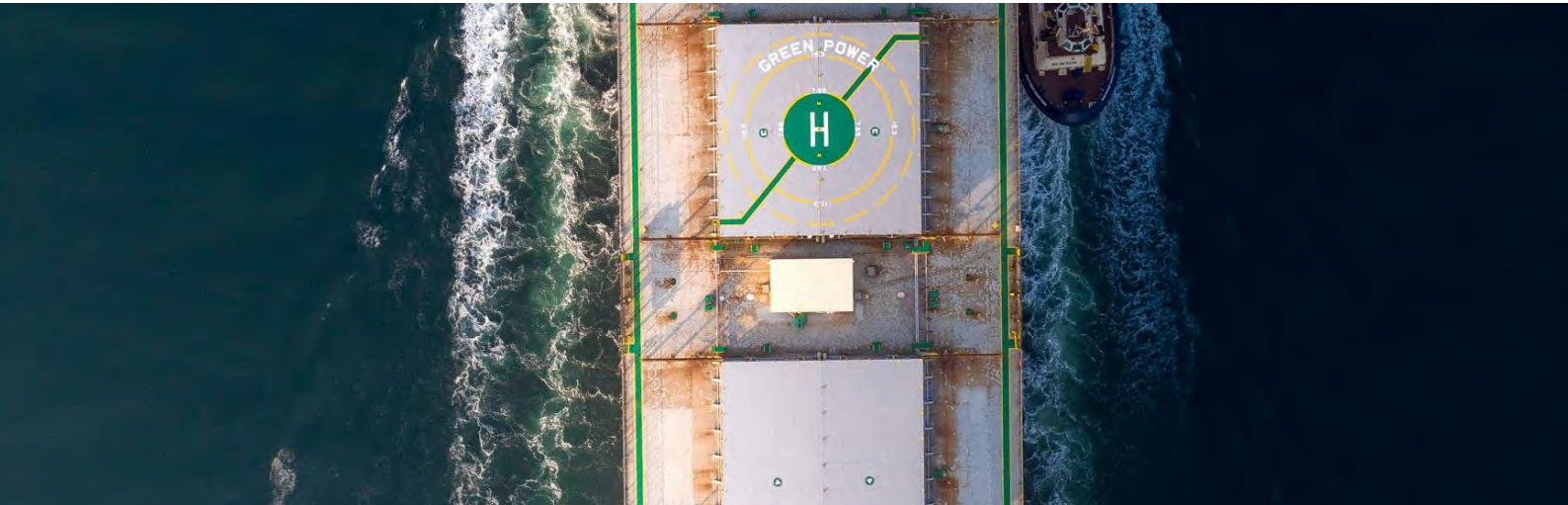


In 2007, Seven Gates Indonesia was established as a sand mining company. We obtained our first mining license under PT Moga Cemerlang Abadi in Banten Province with 22.300 hectares, which is now divided into 13 blocks of sea sand concession.

We expand by creating 10 new sea sand concessions as follows:

Seven Gates Indonesia has two rocks quarries PT. Batu Palu Madu and PT. Hasal Logam. Both quarries are located in Palu, Central Sulawesi.

1. PT. Batu Palu Madu has an area of 37 Ha in Loli Village, Donggala. It is also equipped with two crusher machines, a private jetty and other supporting equipments.

2. PT. Hasal Logam has an area of 36,5 Ha in Watusampu, Donggala. The quarry produces concrete for Sulawesi infrastructure projects. It is equipped with 3 crushers machine, a private jetty and with other supporting equipments.

Dredging Berthing Jetty Area

PT Seven Gates Indonesia takes pride in its partnership with PT Lotte Chemical Indonesia for the LINE Project WP7. We provided top-notch dredging and disposal services at the Jetty Area, covering an expansive area of approximately 52.9 hectares. With a design depth ranging from -18.00 meters to -15.5 meters, we skillfully dredged a total volume of 1,698,033 cubic meters.

The project, situated in Merak, Banten, involved subcontractor Jan De Nul. It commenced on 19th October 2022 and concluded on 7th November 2022, successfully achieving its objectives.

Dredging Sea Water Intake/Outfall Area

PT Seven Gates Indonesia is proud to be working on the Dredging and Dumping Project for PT Lotte Chemical Indonesia. This project involves dredging and dumping at the Sea Water Intake/Outfall Area and Lighters Wharf, covering approximately 4 hectares. The dredging depth varies from -7.00 meters to -18.0 meters, with a total volume of 124,372.61 cubic meters.

The project is located at Jl. Raya Merak Km. 116, Desa Rawa Arum, Pulomerak, Gerem, Cilegon, Kota Cilegon, Banten 42436. The project commenced on 11th June 2023, and we are diligently working towards its successful completion, expected on 31st October 2023
